Report on Annual Members Meeting

LLMC's 43rd Annual Members Meeting was held on July 19 via Zoom due to the pandemic. Key items on the Agenda: Board approved NO INCREASE in Membership subscriptions effective in 2021; Early State Records (ESR); Indigenous Law Portal (ILP) and RIGHTS! Portal (coming soon); Foreign Official Gazettes; AALL Archive; more content for Canada, United Kingdom, Latin America, Germany, Cuba, US States etc. Also, partner updates, including: CRL, Google, AfricanLII, and Library of Congress. The principal business of the annual meeting was elections for LLMC's two governing bodies, our Board of Directors and Advisory Council. Voting rights for delegates reflected each library's subscription status relative to LLMC Digital.

◆ Elections 2020

In the Board of Directors election, two four-year slots were open due to the expired terms of James Duggan, Dir., Tulane U.L.L., and Barbara Garavaglia, Dir., U. Mich. L.L. The Board of Directors nominated James Duggan to another term, especially to serve as Personnel Chair, and David Gee, Libn., Institute of Advanced Legal Studies (London). The Board's nominees were elected by acclamation. In addition, the Board appointed Judy Russell, Dean, U. Florida Libraries, to serve the remainder of Barbara Dewey's term due to her retirement.

In the Advisory Council elections, six councilors' terms expired. Four were nominated and reelected by acclamation: **Glen Dickenson**, Dir, Iowa Leg Serv Ag, **Mary Hemmings**, Dir, Thompson Riv. ULL, **Linda Maslow**, Libn, US Sup Ct L, and **Jean Wenger**, Dir., Chicago-Kent LL. Two new nominees were elected: **Alex Burdett**, Libr., Univ of Victoria and **Ivo Vogel**, Staatsbibliothek zu Berlin - Preußischer Kulturbesitz (Germany).

Our full leadership for 2020/21 appears below. We extend our sincere appreciation to those who have contributed their time and expertise as they have been instrumental in providing important content, counsel, and oversight to LLMC over the years; especially, Barbara for her valued support as Personnel Chair. Barbara has been instrumental in

steering the course of the organization from Hawaii to Minnesota. Our grateful congratulations to all the new incumbents. All of us have already benefited so much, and will no doubt continue to benefit, from the willingness of our colleagues to serve!
